

## I-751 PETITION TO REMOVE CONDITIONS OF RESIDENCE DOCUMENT CHECKLIST

### 1. Conditional Permanent Resident Status

- Copy of Petitioner's Alien Registration card
- Copy of any Conditional Resident children's cards

### 2. Good Faith Marriage

- Affidavit of the client
- Marriage certificate
- Proof of termination of any previous marriages
- Wedding pictures
- Family pictures
- Birth certificates of children they had together
- Letters or cards addressed to both parties
- Letters, cards, e-mails sent from one party to the other
- Letters addressed to either party at the marital address (to show residence)
- Joint leases or rent receipts
- Utility bills addressed to both parties
- Medical records addressed to both parties
- Joint tax returns
- Insurance policies covering both parties
- Joint credit card bills
- Joint bank account statements/checks/deposit slips
- Property deeds in both names
- Magazine subscriptions address to both parties
- Employment records listing names and addresses of both parties
- School or education records listing names and addresses of both parties
- Police, medical or court documents referencing relationship
- Other legal documents/bills addressed to both parties
- Affidavits of people who knew them as a couple or knew their marital address

### **3. Waiver Basis - Battery or Extreme Cruelty**

- Affidavit of the client
- Civil Protection Orders/Restraining Orders (including the petition, affidavits, temporary court order and permanent court order)
- Police reports
- Record of police/911 calls
- Photographs of injuries, damage to property
- Corroborating witness statements
- Medical records
- Criminal court records
- Letters from domestic violence advocates
- Letter from therapist or psychological evaluation
- Letter from shelter re: time spent at shelter

### **4. Extreme Hardship**

- Affidavit of the client
- Medical records indicating necessity for ongoing treatment
- Birth certificates of U.S. citizen children
- School and medical records of children
