## Dear Mr. Gallagher:

The 75 undersigned national, local, and state organizations, concerned about the treatment of immigrants, asylum seekers, and survivors of domestic violence, ask that you immediately release Vilma Viviana Carrillo Carrillo from your custody.

Vilma is a mother from Guatemala who suffered from years of severe domestic violence at the hands of her husband. Now, she is also the victim of a cruel and painful separation from her 11 year-old daughter, Yeisvi. Their story was featured in the New York Times on Friday, November 23, 2018.

After years of enduring beatings from her husband, Vilma decided to take the risk of fleeing Guatemala with Yeisvi. The violence in her home had intensified, and included her husband throwing hot coals at her and knocking out her front teeth. Yeisvi begged her father not to kill her mother. Seeking safety, Vilma and Yeisvi fled Guatemala for the U.S., but on arrival in May 2018 they were separated from each other under the administration's "zero-tolerance" policy. Vilma is currently detained at Irwin Detention Center, in Georgia, while her U.S. citizen daughter is in foster care in Arizona.

Because her mother is in detention, the courts have filed dependency proceedings against Vilma which may lead to the termination of her parental rights. The state's only reason for taking Vilma's daughter is her current detention. ICE has refused her attorneys' requests to release Vilma despite knowing all that is at stake for the mother and her daughter. If Vilma is not released, her parental custody will be terminated and her daughter will be a ward of the state, instead of being in the loving care of her mother, where both can begin to heal from the years of abuse they have experienced.

It is unconscionable and a betrayal of our values as a nation to keep Vilma and Yeisvi apart, especially given the trauma they have experienced. We urge you to facilitate their reunification immediately.
