 IN 2018, TAHIRIH PROVIDED FREE LEGAL SERVICES TO 1,974 IMMIGRANT WOMEN AND GIRLS AND 1,518 OF THEIR FAMILY MEMBERS; CONNECTED 633 CLIENTS AND FAMILY MEMBERS WITH VITAL SOCIAL SERVICES INCLUDING EMERGENCY SHELTER, FOOD AND CLOTHING, AND HEALTHCARE; AND MARSHALED AN ARMY OF 2,451 ATTORNEYS FROM 474 TOP LAW FIRMS IN OUR PRO BONO NETWORK TO LEVERAGE DONATED RESOURCES AND MAXIMIZE OUR CAPACITY. DURING 2018, TAHIRIH ESTIMATED THAT IT RECEIVED APPROXIMATELY 35,000 HOURS OF DONATED PROFESSIONAL SERVICES FROM ATTORNEYS, LEGAL ASSISTANTS AND OTHER PROFESSIONALS.
