IN 2024, TAHIRIH PROVIDED FREE LEGAL SERVICES TO NEARLY 3000 SURVIVORS OF DOMESTIC OR SEXUAL VIOLENCE AND THEIR FAMILY MEMBERS; CONNECTED 396 CLIENTS AND THEIR FAMILY MEMBERS WITH VITAL SOCIAL SERVICES INCLUDING EMERGENCY SHELTER, FOOD, CLOTHING, AND HEALTHCARE; MOBILIZED 1,359 ATTORNEYS FROM 125 TOP LAW FIRMS IN OUR PRO BONO NETWORK TO LEVERAGE DONATED RESOURCES AND MAXIMIZE OUR CAPACITY. WE ALSO EQUIPPED 2,270 ADVOCATES, ALLIES, SERVICE PROVIDERS, AND OTHER FRONTLINE PROFESSIONALS WITH CRITICAL TOOLS TO IDENTIFY FORCED MARRIAGE AND PROTECT VICTIMS.
